## SENIOR CITIZEN SEWER DISCOUNT FOR TRICIA MEADOWS RESIDENTS

### **BASIC REQUIREMENTS:**

1. One spouse 65 years of age or over
2. Total household income of not more than \$10,000 per year, excluding certain Social Security, Federal, State and/or Railroad pensions.
3. Must be being billed by the Mount Laurel Municipal Utilities Authority.
4. Property is deeded in the name of the applicant.

### **REQUIRED DOCUMENTS FOR QUALIFYING:**

1. Proof of age is required such as a Driver's License or Birth Certificate.
2. Proof of income – W'2'S, 1099's, Tax Returns (Federal & State), pay stubs or any other verifiable evidence of income.
3. Proof of residence for Tricia Meadows.
4. Proof that property is deeded in the name of the applicant.

### **LOW INCOME SENIOR CITIZENS DISCOUNT:**

A low income senior citizens discount of 50% will apply to *Sewer Charges* only. Seniors must meet certain income and age or disability standards as defined under "N.J.S.A. 54:4-8:40 et seq." This calls for an annual income not to exceed \$10,000.00, Excluding Certain Social Security, Railroad and Federal & State Pension Benefits and being at least 65 years old or determined to be totally or permanently disabled.
